Fees

Entry/Class Fees: All fees in US dollars. CDE: \$250 for all levels (EI members \$230); CT (Dressage and Cones only): \$150 for all levels (EI members \$130)

Advanced/Intermediate Hybrid: FEI 3*HP1 for horse and pony singles. Contact organizer for pairs/multiples. FEI Para drivers FEI PEA

Ring/Warm-up area Footing: Grass arenas and flat level, grass for warm-up.

Marathon

Marathon will be in Controlled Warm-up format.

Terrain: Pasture, forest trails, dirt and gravel roads. Can be bumpy in places. Hilly in places. Wildlife may be encountered.

Training: all turnouts Section B: 4-7 km total; 5 obstacles, each with 3 gates

Preliminary: all turnouts Section B: 5-8 km total; 6 obstacles, each with 4 gates

Intermediate: all turnouts Section B: 5-8 km total; 7 obstacles, each with 5 gates

Other: Mandatory safety check 15 minutes before your Marathon go.

Cones

Ring/Warm-up area Footing: Grass/Grass

Training, Preliminary, Intermediate: Minimum clearances by class and vehicle width per Article 973.1.7

Advanced/Intermediate Hybrid: standard clearances per FEI rules.

Wheel Track Measurements: Taken on Friday. Please contact the event office to get your vehicle measured for Cones.

Other: No bridges or water crossings for Cones. Planned opening for course inspection by 2 p.m. Friday. Reminder that helmets are required in Cones per ADS rules.

Other Information

Medical Armbands or equivalent such as Road ID are required of all persons on a carriage at any time during the event.

Courses and arenas will be closed for schooling with your horse for the 30 days before this competition.

Stabling Information: Portable stalls with roof. Initial shavings provided. Additional shavings will be available onsite. Final cleaning provided.

Veterinary / Equine Health Requirements:

To promote health and welfare of all horses, Equestrians Institute complies with ADS and State rules regarding horse welfare, including but not limited to:

- Proof of vaccination or veterinary exemption for Equine Influenza Virus and Equine Herpes Virus current within six months prior to the opening of the event. See ADS Art. 6.3.
- All out-of-state equines require negative Coggins current within six months prior to the opening of the event. Vet health certificate required for horses coming into Oregon. Please check with your vet for particulars, as state requirements have changed.

Human Health Participation Requirements:

Driver/Groom allowed more than once around marathon? Competitors and navigators may compete more than once **ONLY IF schedule permits**. Sharing of carriages, navigators, more than once around – subject to advance scheduling only as listed on driver's entry. Request must be included with driver's entry to be considered.

VSE/Pony Measurement: All ponies and VSEs must be officially measured per ADS rules and must compete in their designated divisions. Please submit a file copy of your official ADS measurement card with your entry. If you have already provided to an EI event a pony card which is still valid, it's on file and no need to resubmit. If you do not have an official measurement card, please notify registration secretary.

Para Drivers and drivers needing dispensation for disabilities, please contact the ADS to secure your certificate. This certificate must be included with your entry.

Awards Offered: Ribbons through fifth place. Special merit awards. Classes may be combined for awards.

Misc. Show info:

- No lunging in camping/parking area.
- Stalls and camping/parking spots to be assigned. Must include total length of rig on entry form (truck/RV plus trailer length). Please list preferences on entry form and we will do our best to accommodate.
- Dogs must be on leash in permitted areas and under control at all times.

Food Available on the Grounds: Yes. Concessions for breakfast and lunch Saturday/Sunday.

Accommodations: Choice of motels nearby, 20 minutes away. Contact organizer for more information.

Camping on Grounds: Yes, no hook-ups. Only if you have special medical needs, please contact the organizer in advance. There is a \$15 per night fee for electrical hook-up for medical equipment.

Camping off Grounds: Contact organizer if help needed.

Directions to Show:

26250 S Lazy Excess Lane, Beavercreek OR 97004

From I-205, take Exit #10 (Oregon City/ Molalla Exit). This exit puts you on Hwy 213 heading SW. You'll immediately go through 2 stoplights and then drive for approximately 3 miles to the 3rd stoplight. Take a left at the 3rd stoplight, which is Beavercreek Road. Stay on Beavercreek Road for approximately 3 miles and you'll enter the very small Hamlet of Beavercreek. In town, Beavercreek Road takes a very hard left, follow it. After 2 more miles, you'll climb a very long, steep hill with a church on the right. At the top of the hill, go 1 more mile and take a right on to S. Larkin Road (it is hard to see and only goes to the right). Take S. Larkin Road to the very end (2 miles) and it will T with Buckner Creek Road. Take a right on to Buckner Creek Road and stay straight for approximately 1 mile (you'll pass Howards Mill Road, then Jones Road on the left). Lazy Excess Lane is the next road to the left with a wide entrance and 2 open wrought-iron gates. Drive through the gates and stay straight following welcome signs to the camping area. Please stay under 10 mph.

Additional house rules specified by Lazy XS Ranch:

- Park horse trailers in designated trailer parking area only. (EI will send out parking maps as we usually do.)
- Volunteer parking in designated areas only.
- Keep fire lanes open at all times.
- No open fires.
- Dogs allowed only if on leash at all times. Pick up after your dog.
- Use manure wagons to dispose of stall manure only.
- Pick-up your garbage and place it in cans.
- No stall construction changes allowed. Any damage to stalls will incur a damage fee.
