## Equine Vaccination Requirements

According to [USEF GR844](#), At Federation licensed competitions horses, more than 7 months of age, entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the stables.

1. **All horses are required to provide proof of vaccinations no later than 5:00pm on the Wednesday before the show.** If we do not received your vaccination records, you will not be allowed on the grounds, and we will not refund your entry or any associated fees.
2. Negative EIA/Coggins within 12mo is required for all out of state entries.
3. Health Certificates are required for all out-of-state competitors.

If you plan on competing in both shows, you will need to fill out a separate entry for each show. The office & USEF drug fee will apply to each as does any applicable USDF and USEF fees above. Please put stabling on the first show of your entries.

The Washington State Horse Park requires all stalls to be stripped prior to departing. If you want to strip the stall yourself there is NO CHARGE. However, if you want the HP facility staff to strip the stall for you, make sure to pay the \$20 fee when you submit your entry.

# Awards

## Awards

- All show entrants are eligible to win class ribbons.
- Ribbons awarded to 6th place for all classes. In some classes ribbons may be awarded to 8th place.
- Additional prizes to 1st place winners in classes may be awarded at discretion of show management.
- Certain classes have monetary prizes, medals, or other awards; see each show prize list for details.
- Some individual breed organizations make awards (ribbons &/or prizes) either at the shows or mailed from their offices. Check with your breed organization for participation at our shows, requirements and criteria.

### Equestrians Institute Show Awards

Available for EI members only. Don't forget to renew your membership NOW so you can be sure to qualify.

- Show High Point Awards (ribbon and gift certificate) are awarded for highest scoring Junior/Young Rider, Adult Amateur, and Open Rider. Only ridden Training through Grand Prix classes, excluding Freestyles and Equitation classes, will count. Must be an EI member when scores are earned.
- Champion and Reserve Pony *Breed* Awards to top two highest scoring rider/pony breed combinations from the weekend. Submit breed papers with entry.
- Perpetual Trophy Awards:
  - Suzy Moery Perpetual Trophy - 2nd Level
  - Mary Dodd Perpetual Trophy - 3rd Level
  - Kathleen Doyle - Musical Freestyle



### Equestrians Institute Year End Awards

Available for EI members only. Don't forget to renew your membership NOW so you can be sure to qualify.

- Scores must be earned while a current EI Member
- Only ridden Training through Grand Prix classes count, excluding Freestyles and Equitation classes
- Scores qualify for current competition year (Oct 1 – Sept 30)
- One horse/rider combination will be considered an entry
- OPEN – Ribbon and gift certificate
- AA – Ribbon and gift certificate
- JR/YR – Ribbon and gift certificate



### National Dressage Pony Cup

Pony classes ridden at this competition qualify for NDPC Year-End Awards the rider is a NDPC member. Learn more at [www.dressageponycup.com](http://www.dressageponycup.com).

- **New Award Structure for Equestrians Institute shows this Year:**
  - Champion and Reserve Champion will be awarded for each show separately from the NDPC Pony only classes. The Champion and Reserve Champion ribbons will be awarded Saturday for Crystal, and Sunday for Magnum.
  - A Weekend High Point and Reserve High Point will be awarded based on the total cumulative points each rider/pony combination earns over the weekend in the NDPC Pony only classes. The Weekend High point and Weekend Reserve High Point ribbons will be awarded on Sunday. **Entrants must compete both Saturday and Sunday to be eligible for Weekend High Point awards.**
- To be eligible to compete in the NDPC Pony Only classes a USEF Measurement card must be on file with the USEF.
- NDPC Year-End Awards: All tests and freestyles ridden in Pony classes will automatically be entered in NDPC Year End Awards.



### USPRE PNW High Point Series

Designed to encourage PRE riders of all levels to train and compete in recognized shows. The Pacific Northwest series consists of five events (two show weekends will be considered one event for the purposes of the Series), giving expanded opportunities in 2025 to participate in the program.

- To be eligible for participation all PRE's must be USPRE Members (horse and rider or horse owner) and declare participation prior to competition by completing the "Declaration of intent for USPRE Dressage Programs" form found on the USPRE website. Declaration is only required once for the show year.
- High Point winners will be pinned at each show in six different divisions (Open National, Open FEI, AA National, AA FEI, JR/YR, CDI).
- Minimum scores of 62% are required to be eligible and freestyle scores do not count towards the series.
- At the completion of the series a grand champion will be determined by the sum of their three highest scores at the same level from two separate shows. Additional rules and information can be found at [www.usprea.com](http://www.usprea.com).

# Competition Rules

---

## **EVERY CLASS OFFERED HEREIN WHICH IS COVERED BY THE RULES AND SPECIFICATIONS OF THE CURRENT UNITED STATES EQUESTRIAN FEDERATION RULE BOOK WILL BE CONDUCTED AND JUDGED IN ACCORDANCE THEREWITH.**

1. **ADDITIONAL SHOW PERSONNEL:** Veterinarian and Farrier will be on call; names and contact information will be posted at the Show Office. First Aid available from EMT/Medical Personnel on grounds during competition hours.
2. **ENTRIES:** Observe opening and closing dates published on the title page. Entries received before opening date will be penalized. Telephone or email entries will not be accepted. Entries will be accepted on a first-come, first-served basis until available ride times are filled. Subsequent entries will be wait listed. All entries received by closing date will be confirmed via e-mail. Please contact the Show Secretary if you have not received a confirmation email by one week after closing date. No entry will be accepted without payment of fees, either by check or credit card on Horse Show Office (<https://horseshowoffice.com/#/events>). All information and signatures must be clearly legible. All competitors, by completing their entry, acknowledge and attest that they have read and understood all terms of these rules, wherever listed in this prize list. Management may deny entry to any competitor if the competitor has outstanding debt to the sponsoring organization.
3. **USEF SHOW PASS:** Riders and Owners are now only eligible for one (1) Show Pass (or non-member fee) per year. This fee must be purchased online from USEF. The Show Pass is only good for one competition. Trainers and Coaches are no longer eligible to be non-members or use a Show Pass. Trainers and Coaches must be members and this includes parents that sign as trainers and coaches.
4. **ONLINE ENTRIES: Online show entries through Horse Show Office are required.** Payment can be made via credit card or check. Payment may also be mailed to Equestrians Institute c/o Anne Bartlett, 13445 125<sup>th</sup> Avenue NW, Gig Harbor WA 98329. Included printed entry from Horse Show Office with check. There are no processing fees for submitting payment online. **All signature pages must be printed, signed, scanned, and uploaded to each online entry.**
5. **SAFE SPORT: Reminder: All USEF Life and Senior Active members, as well as participants who have regular contact with minor athletes, are required to comply with the U.S. Center for SafeSport training requirement to be eligible to participate in the competition.** All participants must adhere to the U.S. Center for SafeSport Code, USEF Safe Sport Policy, and the Minor Athlete Abuse Prevention Policies. More information about these can be found at [www.usef.org](http://www.usef.org).
6. **WAITLIST ENTRIES:** A waiting list will be established once all ride times have been filled. Those who choose to remain on the waiting list but do not get into the show will have their entry check destroyed (not cashed) and no fees will be assessed. Online payments will be refunded via PayPal, minus the PayPal service fee.
7. **INCOMPLETE OR INACCURATE ENTRIES:** Proof of registrations and memberships must be provided with each entry. All signatures must be present. Competitors will be assessed a fee of \$20 for missing signatures or information. Bridle numbers will not be awarded at show until all fees are paid.
8. **POST ENTRIES:** Management reserves the right to accept post entries if space allows or in case of cancellation. Post entry fee: \$20 per entry (horse/rider combination). Online entries will close at midnight on entry closing date. Post entries must be submitted and paid through Horse Show Office. No mail-in post entries will be accepted.
9. **REFUNDS:** A) 100% (except for the \$35 Office Fee) before the show's closing date. B) After the closing date and upon presentation of a Veterinarian or Doctor's certificate, there will be a refund of 50% of the class fees, 100% of the USEF drug fee, 100% of any USDF qualifying fees, and stall fees. The Veterinarian or Doctor's certificate must be received before noon of the Monday before the competition to be considered for the refunds listed in section B of this rule. There will be no refund of the Office fee. No refunds of any type will be made if notice of cancellation is received later than the deadline of the Monday before the competition. No refunds will be made if the entry is a no-show. Equestrians Institute reserves the right to cancel, without refunds to the riders, all or part of the competition including individual classes, due to a storm, acts of God, accident or other emergency. Qualifying fees for rides scratched at the show will be refunded, if picked up in person at the show office. Qualifying refunds will NOT be mailed or processed through PayPal in this case.
10. **DRUGS AND MEDICATIONS:** A \$23 Federation fee, of which \$15 is the USEF Equine Drugs and Medications fee, will be assessed per horse, per show.
11. **FEES:** Please see Show Fees list for all current fees.



12. RIDE TIMES: **Tentative** ride times will be posted online no later than 5 days before the competition with notice emailed to all riders. It is the responsibility of the rider to inform the show secretary of any time conflicts as soon as possible after the tentative schedule is posted. The **official and final ride times will be posted in the Show Office**. Ride times will not be mailed; it is the responsibility of the exhibitor to obtain his/her ride times from competition management or from posted sources.
13. COMBINATION/CANCELLATION OF CLASSES: Show Management reserves the right to combine or cancel classes where fewer than three (3) horses are entered or to limit the size of a class as necessary. Show Management also reserves the right to change the order of the classes as they are listed in the Prize List. Competitors in changed classes will be notified per USEF GR 830. Classes cancelled because of weather may be rescheduled or remain cancelled. NO REFUNDS.
14. TEST OF CHOICE (TOC) CLASSES: A horse may compete only once in any class including Test of Choice. There will be no changes in your Test of Choice selected after the entry form is processed, except with payment of \$10 Entry Change Fee. If no test choice is specified on the entry form, management will assign the highest test of the level.
15. QUALIFYING/NON-QUALIFYING CLASSES: At each level, the highest test of that level may be designated a Qualifying ("Q") class for the 2025 Great American Insurance Group/USDF Regional Championships. Eligibility requirements for Q classes: **Rider** must be USDF Participating Member and USEF Life or active member. **Owner** (if multiple Owners, only one Owner) must be: a) USDF Participating or Business Member, b) an Active Member of USEF and c) must be the owner of record with USDF and USEF. **Horse** must have current annual or lifetime recording with USEF; USEF Horse ID is not sufficient. Horse must be USDF lifetime registered; USDF Horse ID is not sufficient. \$20 qualifying fee must be paid on the entry. Qualifying fees for rides scratched at the show will be refunded or reapplied to cover indebtedness to the competition by the competitor. Refunded fees MUST be picked up in person at the show office. Qualifying refunds will NOT be mailed in this case. See [USDF.org](http://USDF.org) for additional details.
16. OPPORTUNITY CLASS: Opportunity classes are intended for entry level participants. Horses, riders, owners, trainers, and coaches participating only in Opportunity classes are exempt from Federation and affiliate organization membership and Horse Identification (HID) requirements and non-member fees. Riders are required to list the Federation membership number if the participant is a member. Horses entered in Opportunity classes are subject to and must comply with all Drugs & Medications rules, including vaccinations, and are subject to testing but are exempt from the Federation fee. Opportunity class riders may compete wearing breeches and shirts of any color as permitted in DR120. Jackets or vests of any type are allowed but not required and neckwear may be worn only if the rider chooses to compete in a riding jacket. Boots and protective headgear are required as specified in DR120.1.6. Scores earned in Dressage Opportunity classes may not be used towards USEF or USDF awards or programs. See USEF GR821 for complete rules. **Cross-entry between Opportunity and other classes is allowed; however, the above exemptions apply only to the Opportunity Classes.**
17. MUSICAL FREESTYLES/ SOUND CHECKS: Music must be emailed to the show secretary no later than the Wednesday before the show, or brought to the show office on a USB drive at check-in. Accepted formats for music are MP3/WMA or MP4. **Sound checks will be held from 5:30pm-6:30pm on Friday of the competition weekend in the covered arena.** Riders who are unable to accommodate the Friday soundcheck due to extenuating circumstances, should contact show management to make alternate arrangements. Effective December 1, 2019 - DR129.9: Except for USEF/USDF Championship classes and for FEI Pony Riders, FEI Junior, FEI Young Rider, and FEI Para-Equestrian Freestyles, in order to enter a freestyle class at any level, a horse/rider combination must have received a minimum score of 63% for Training through Fourth levels and 60% for FEI levels in the highest test of the declared freestyle level or any test of a higher level at a USEF/USDF licensed Dressage Competition, Federation Licensed or FEI recognized Dressage Competition, or "open" Dressage class (i.e. open to all breeds) at a Federation Licensed Competition held prior to the competition where the horse/rider combination is entered to ride a freestyle class. A photocopy of the test verifying eligibility, or copy of the USDF score verification, must be submitted with the entry for a freestyle class. Specify level of freestyle on your entry.
18. SCHOOLING ENTRIES: Horses brought onto the grounds but not entered in the show must be registered with the Show Office and will be given a number to be worn at all times outside of the stall. Schooling-only entries are subject to the same rules as competing horses with additional restrictions on the times and general use of any facility amenities. Any person(s) riding a schooling horse must submit an official entry blank and signed release forms. Appropriate stall fees and schooling fee per show must be paid in addition to the Office fee for each show. Horses entered as schooling-only but later converted to class entries must pay all additional fees as required for entry.
19. NO SHOWS (or Scratches): All "No Shows" that have not checked in with the show office a minimum of 45 minutes prior to their first ride and picked up their exhibitor numbers will be considered a "scratch" for the rest of the show and their ride time slots may be filled. There are no refunds for scratched entries or classes. Scratches by competitors on the show grounds are official ONLY when made to the Show Secretary. Scratches made to warm-up or ring stewards are not official and may be considered NO SHOWS. If the competitor cannot come to the show office to scratch in person, they may send a representative.



20. ARENAS: All tests, except Para Equestrian Grades 1-3 as required, will be ridden in a standard sized (20x60m) competition arena with sand or sand/rubber footing. Warm-ups may be done in designated arenas. Lunging is permitted in designated areas only.
21. STABLING: All Stalls are portable 10' x 10' with solid walls and full doors. One bag of shavings is provided with each stall. Additional bags may be purchased. Stall charts will be posted online and check-in will start at 12:00 PM on Friday prior to show. Stalls may not be resold or sublet by an exhibitor.
22. STALL BEDDING: First bedding is provided. Additional bedding can be purchased at the show. Cost for additional bedding is \$15 per bag; requests for purchasing additional bedding can be made at the Show Office. **All stalls need to be stripped prior to departure from the facility.** Those not adequately cleaned will incur \$20 cleaning fee.
23. ARRIVALS and DEPARTURES: Early arrivals & late dismissals are possible only by direct arrangement with the Washington State Horse Park. **Stalls will be available after noon (12pm)** the day prior to the first day of competition.
24. CONCESSIONS: Concessions are available at show grounds during show hours.
25. DOGS: Per USEF Rule GR1301.6: Dogs are not permitted to be loose on competition grounds and must be held on a leash or otherwise restrained. Individuals must not lead dogs on a leash while mounted. Dog owners are solely responsible for any damages, claims, losses, or actions resulting from their dogs' behaviors. Dog owners failing to comply with this rule will be issued a Yellow warning card and may be subject to penalty under [USEF General Rules] Chapter 7.
26. CAMPING: A limited number of RV spaces are available. All RV spaces have water and 30 amp electric hookups. Designated spaces also have sewer and are wooded. No horses are allowed in the back-in RV spaces. Reservations are required for RV camping spaces with associated fees paid (\$45 per day/night). Fee applies even if only day use, and whether hooked up to utilities or not. Dry camping is available to any adult staying onsite overnight not in an RV hooked up to utilities. Fee of \$10 per night per adult cover costs for showers, porta johns and trash.
27. SHOW OFFICE HOURS: Open one (1) hour prior to the first ride each day and will close one-half hour after the last class of the day. The day before the competition starts, the office will be open 2PM - 7PM.
28. LOCAL ACCOMMODATIONS: Make reservations early. Available area hotels are Best Western Snowcap Lodge, Cle Elum (509-674-0200), Timber Lodge Inn, Cle Elum (509-674-5966), Quality Inn near Suncadia Resort, Cle Elum (509-674-2380), Stewart Lodge, Cle Elum (877-233-5358), Cle Elum Traveler's Inn, Cle Elum (509-674-5535).
29. DRIVING DIRECTIONS: Address: 1202 Douglas Munro Blvd, Cle Elum, WA 98922. **From I90 Eastbound** - Take Exit 84; after exit ramp take first left (between Windermere and Warrior Quick Stop gas station) onto Douglas Munro Blvd., stay on this road as it quickly turns left and proceed 0.7 miles past cemetery to entrance to the Horse Park. **From I90 Westbound** - Take Exit 84; at end of exit ramp turn right onto Oakes Ave., proceed 0.5 miles to light; make left onto W. First St. and continue 0.7 miles; make right (between Windermere and Warrior Quick Stop gas station) onto Douglas Munro Blvd., stay on this road as it quickly turns left and proceed 0.7 miles past cemetery to entrance to the Horse Park.
30. AWARDS: Prizes to first place in classes of three or more riders, except Opportunity Classes where prizes and ribbons will be awarded independent of the number of class participants. Ribbons to 6<sup>th</sup> place for Open Divisions. Ribbons to 8<sup>th</sup> place for Adult Amateur Divisions and Jr/YR Divisions. High Point Ribbons will be awarded for Open, Adult Amateur, JR/YR, and Pony Breed when considering combined scores from the entire show weekend. Designated classes may have additional prizes.
31. HELMETS: From the time horses are officially admitted to the competition grounds by competition management, anyone mounted on any competition or schooling entry must wear protective headgear, defined as a riding helmet which meets or exceeds ASTM/SEI standards for equestrian use and carries the SEI tag. The harness must be secured and the helmet properly fitted. In addition, Effective 12/01/2015 as per USEF DR 206.6, **ALL Handlers, Assistant Handlers and Whip Assistants** are required to wear protective headgear, defined as a riding helmet which meets or exceeds ASTM/SEI standards for equestrian use and carries the SEI tag, with the harness properly fitted and secure when in the competition ring.
32. DRESS CODE: Management may announce prior to or during a competition that competitors can show without jackets due to extreme heat and/or humidity. If jackets are waived, competitors must wear a shirt with sleeves and collar, without neckwear, and without decoration. Eliminations are mandatory for all dress code violations as specified in USEF rules.
33. SHARPS CONTAINERS: Approved sharps containers can be found on the show grounds. Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments.

34. **PONY MEASUREMENT:** Any request for an official pony measurement must be made in writing at least five days prior to the start of the competition weekend. Pony measurements, with veterinarian and TD present, will be held the evening before the show begins at 5:30pm. Pony measurements will take place in the designated area near the stabling. Each pony measurement carries a \$25 fee payable directly to the Show Office. An alternate date or time for a pony measurement may be scheduled via written request to the Show Secretary at least five days prior to the start of competition. There will be a charge of \$100 per measurement held at an alternate date or time. Please email Anne Bartlett ([anne@aldensimage.com](mailto:anne@aldensimage.com)) to schedule measurement.
35. **FEI PARA:** Para Equestrian riders must have current International (FEI) or National (USEF) Dispensation Certificate indicating classification status. Riders, horses and owners are no longer exempt USDF membership requirements. All tests for para equestrians are ridden in a standard (20m x 60m) arena, except Grade I- III freestyles are ridden in a shortened (20m x 40m) arena. For more info see <https://inside.fei.org/> or [USEF.org](http://USEF.org).
36. **RELEASE OF RESPONSIBILITY:** USEF, USDF, Washington State Horse Park, Equestrians Institute, Show Officials, Show Management, and/or employees and volunteers will not be responsible for any accident and/or loss that may occur to any person, exhibitor or his agent horse and/or equipment. Washington State Equine Limitation of Liability Act RCW4.24 applies to all Equestrians Institute shows, at any facility used. Horses, by their inherent nature present a risk of injury, harm or death. Riders represent that they are qualified to participate at the level entered. Each exhibitor is responsible for any injury or harm, that may be occasioned to any person, whomsoever, by any horse owned or exhibited by said exhibitor, and shall hold harmless and indemnify any agencies or persons listed above, against all claims or demands, of any nature or kind, that may grow out of any injury occasioned by any horses owned or exhibited by them, or arise from the negligence of the person in charge of such horse. All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents or their horses. All horses exhibited at these shows participate entirely at the owner's or rider's risk.
37. **SPECIAL RELEASE:** By signing the entry agreement, I further agree to: "release, indemnify and hold harmless USDF, its instructors, officers, directors, agents, and volunteers from and against any and all loss, liability or damage arising from or because of, or in connection with, participation in this competition or related activities. I also hereby agree to release, indemnify and hold harmless the show management, show committee and members, officers, directors, agents, and volunteers from and against any and all loss, liability or damage arising from or because of, or in connection with, participation in this competition or related activities."
38. **VACCINATION RULE:** (See USEF GR 844 for details) Exhibitors are reminded of USEF's vaccination policy, applicable to horses more than 7 months of age. Vaccination must be submitted with your entry. Non-compliant entries will be denied entry and permission to unload and will not be allowed to mingle with other horses or compete. No refunds will be given if the right to compete is denied because the Vaccination Record is missing or incomplete. *Whether the horse is vaccinated by a veterinarian, or by an owner or agent, **documentation is required.*** Upload or email the appropriate, completed and signed documents prior to the Friday before competition arrival begins.
39. **NATIONAL DRESSAGE PONY CUP PARTNER SHOW CLASSES:** Ponies must meet USEF/USDF height requirements, DR 135.1 and have a valid USEF measurement card or be measured at the show (See Rule 34). EI Ribbons awarded for each of the classes. NDPC Year-End Awards: Show management may allow non-member ponies to compete in the pony only classes. Ponies that are not members are not eligible for NDPC Year-End Award prizes. To be eligible to compete for NDPC Year-End Awards, competitors must be current members by the NDPC designated deadline. 40. **INTERSTATE TRAVEL:** Exhibitors are reminded that State entry requirements apply to horses entering Washington and returning to the state of origin or elsewhere. These requirements vary from state to state. Always confirm state requirements for equine travel to and from WA. "Interstate Livestock" may be helpful: <https://www.interstatelivestock.com>.

## **USEF Biosecurity Requirements**

Effective 12/1/24

### **Competitor Requirements (GR870)**

All riders, drivers, vaulters, handlers, owners, trainers, coaches, grooms, agents, and lessors must abide by and comply with biosecurity measures and equine health requirements imposed by the Federation, Competition Management, and local, state, and federal animal health officials.

### **Competition Management Requirements (GR871)**

Competition Management must ensure licensed competitions are conducted in accordance with all applicable Federation, local, state, and federal animal health requirements.

### **Mandatory Reporting of Febrile Horses (GR873)**

The trainer, as defined by Federation rules, or the owner if the trainer is unavailable, or the rider if the trainer and owner are both unavailable, shall notify the competition veterinarian and Competition Management as soon as possible but no later than two hours after detection of any febrile horse or pony. A febrile horse or pony is one with an unexplained temperature above 101.5°F at rest (i.e. two hours after exercise or transport). If a febrile horse or pony is detected outside of competition hours or before the competition begins, notification must occur as soon as possible but no later than one hour detection of the fever above 101.5°F.

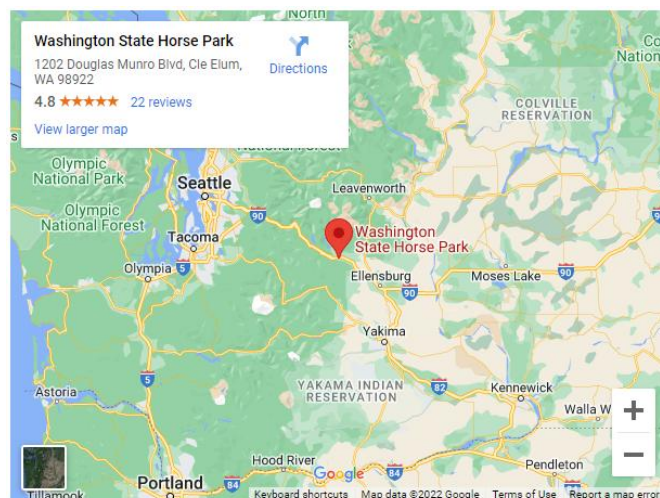

### Regional Adult Amateur Equitation Program

The USDF Regional Adult Amateur Equitation Program recognizes adult amateurs competing in equitation and promotes correct seat, position, and use of the aids in dressage. An Adult Amateur Equitation Regional Final class presented by Big Dee's Tack and Vet Supply will be held in conjunction with each of the nine USDF Regional Dressage Championship competitions, providing adult amateurs with additional opportunity for recognition. Ribbons awarded through 8<sup>th</sup> Place and gift certificates awarded to top four riders.

Adult amateurs wishing to qualify to compete in an Adult Amateur Equitation Regional Final may do so by meeting the following requirements.

#### Qualifying Requirements

To be eligible for the USDF Adult Amateur Equitation Regional Final class, rider must have

a) Earned a score of 70% or higher in any dressage seat equitation class (except walk/trot) at a USEF-licensed/USDF-recognized Dressage competition within the qualifying period of the applicable regional championship.

*or*

b) Qualified to compete in any regional dressage championship class (excluding freestyles).

#### Membership Requirements

- Rider must have a USDF Participating Membership at the time the qualifying score is earned, and at the time of the Regional Final class.
- Rider must be an adult amateur, in accordance with GR1306 of the USEF rules, and be designated with USEF as an adult amateur when the score is earned, and at the time of the Regional Final class.
- Owner must have a USDF Participating or Business Membership when the qualifying score is earned, and at the time of the Regional Final class.
- Horse must have a USDF Lifetime Horse Registration when the qualifying score is earned, and at the time of the Regional Final class.

# USDF Statement on Animal Welfare

The United States Dressage Federation, Inc. (USDF), a federation of individual members and over 100 independent organizations throughout the United States, supports the concept of ethical treatment of animals.

Dressage is a classical method of training horses, based upon the horse's natural responses, as carried out in a gradual, planned program during which the horse's athletic abilities are improved in a systematic manner. As a result, the horse becomes capable, comfortable, and responsive in partnership with the rider without the use of force. Dressage competition at various levels of achievement is the ultimate test of the training program to determine whether the desired harmony between horse and rider has been achieved.

The rules pertaining to dressage competition prohibit the use of artificial appliances, training aids, and drugs, which would force the horse to submit. Instead, the emphasis is upon training and a cooperative partnership with the rider. Major competitions are carefully monitored to assure that there is no unnecessary force or harshness displayed.

Unlike other horse sports in which horses enter training at a relatively immature state, dressage training is usually not seriously begun until the horse is three or four. The top levels of achievement require five or more years of progressive training and it is not unusual to see horses in international competition in their late teens. This, in itself, places a premium on good care and soundness throughout the horse's life.

While supporting the concept of animal welfare in its broadest form, the United States Dressage Federation, Inc., also recognizes that it is unrealistic to ascribe human emotions and responses to the horse which in its wild state is a creature of flight, living a hard and precarious existence. Under domestication, the horse is assured of ample food, water, and shelter, as well as protection against infectious diseases and damaging parasites, thus leading a longer and healthier life with a high rate of survival.

As an educational organization, USDF has numerous programs, which teach people how to pursue the accepted, humane training methods. A program of certifying instructors also emphasizes protecting the horse's welfare in pursuit of dressage training.

**Membership Requirements for USEF-licensed/USDF-recognized Competitions:** Owners and riders, including foreign riders and owners who are not residents of the US, wishing to participate in a USEF-licensed/USDF-recognized competition as a rider or owner/lessee, must have either a USDF Group Membership (GM), Participating Membership (PM), or have a USDF Non-Member (NM) identification number and pay the USDF Non-Member (NM) fee. (Note: USDF Business Members can own horses but cannot compete as riders with their USDF Business Membership.)

Horses competing at USEF-licensed/USDF-recognized competitions must have either a USDF Horse Identification (HID) number or a USDF Lifetime Horse Registration (LHR). Proper credentials or verification certificates must be presented to the competition secretary.

Riders and owners wishing to participate in a USEF-licensed/USDF-recognized competition, and not able to present the competition secretary with verification of a USDF membership or NM identification, and USDF LHR or USDF HID, must complete a USDF Competition Affidavit Form and pay the \$5 affidavit filing fee. A copy of a completed affidavit form from another competition may also be used for verification purposes for up to 60 days. (Exception: Affidavits cannot be used at Great American Insurance Group/USDF Regional Dressage Championships.)

#### Exceptions:

- Horses competing only in Individual Breed Classes (IBCs) at DSHB competitions, sires and dams of horses in DSHB group classes, where those sires or dams are not actually competing in the same competition, horses competing only in breed restricted dressage or DSHB classes at Regular Competitions (e.g. all Arabian, all Friesian, or all Morgan classes), or in USDF Introductory Level tests, pas de deux or quadrille, are exempt from this requirement. Also exempt are horses ridden in leadline, exhibitions, games and races, classes for 4-H members, walk-trot, academy, and opportunity classes.
- Riders and owners/lessees competing only in classes which are exempt from the USDF HID requirements are also exempt from the USDF NM identification number and NM fee requirements. Also exempt are handlers of horses competing in DSHB In-Hand or Group classes.

#### Memberships Defined

**Participating Membership (PM):** A membership issued to an individual directly by USDF. The membership year is December 1 through November 30. PMs are available for 1-year (\$100), 5-years (\$400), or life (\$2,000). A USDF Youth Participating Membership (YPM) is available for individuals who have not reached their 21st birthday by December 1 of the current membership year (\$80). A PM allows the member to compete at USEF-licensed/USDF-recognized competitions and to participate as a rider and/or owner/lessee for all Adequan®/USDF Year-End Awards and the Great American Insurance Group/USDF Regional Dressage Championship program.

**Group Membership (GM):** A membership issued to an individual by USDF when the member name and dues are submitted to USDF through an affiliate Group Member Organization (GMO). The GM year begins December 1 and ends November 30. A GM allows the member to compete at USEF-licensed/USDF-recognized competitions and participate in the USDF Rider Awards Program and the USDF Regional Schooling Show Awards Program.

**Business Membership (BM):** A membership that runs December 1 through November 30 and is issued to a business or organization directly by USDF. The USDF BM (\$280) offers a wider variety of advertising benefits. BMs satisfy requirements of horse ownership only.

**Non-Member (NM) Identification Number:** For each USDF NM owner/lessee and USDF NM rider there will be a USDF NM fee of \$55 per competition that must be collected by the show secretary and submitted to USDF, along with the USDF Report of Fees document and the \$5 affidavit fee and Competition Affidavit Form if the person cannot provide a copy of their USDF NM card. Owners/lessees or riders exempt from the NM number requirements are also exempt from paying the USDF NM fee. If there are multiple owners of a horse and all are NMs, only one of the owners must pay the NM fee. If the horse has at least one owner who is a current USDF PM, GM, or BM there is no NM fee assessed. Competition management will be invoiced for all applicable USDF NM fees not received with the USDF post-competition paperwork, along with a report listing all USDF NMs. Competition management is then required to submit the NM fees within 30 days to the USDF. An individual with a USDF NM identification number is not eligible for any USDF membership benefits. Once a USDF NM number has been assigned, a USDF NM card can be obtained from the USDF website.

**Horse Identification (HID) Number:** A one-time tracking number for horses (\$45). Scores earned by a horse with an HID number will be recorded but will NOT be counted towards Adequan®/USDF Year-End Awards. A horse with an HID number is not eligible to compete in Great American Insurance Group/USDF Regional qualifying or championship classes. An HID number can be upgraded to a Lifetime Horse Registration (LHR) for a fee of \$95. If a horse has a USDF LHR it does not need an HID number. An HID number is a one-time fee that does not need to be renewed.

**Lifetime Horse Registration (LHR):** A horse with an LHR (\$140) is eligible for Adequan®/USDF Year-End Awards, and eligible to compete in Great American Insurance Group/USDF Regional qualifying and championship classes, assuming requirements for the owner and rider are met. If a horse has an LHR it does not need an HID number. An LHR does not need to be renewed.

The effective date of membership is the date the form and correct fees are received in the USDF office or, if applying at a competition, the date accepted by the competition secretary, provided the application is signed and dated by the competition secretary, member, and/or horse owner on that same.

## **USEF MEMBERSHIP STATEMENT**

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Modified Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A non-member may participate as a handler, rider, driver, owner, lessee, or agent at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) assistant handlers in Dressage Sport Horse Breeding classes

## **USEF MOTORIZED VEHICLE STATEMENT**

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind, including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles, on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. The parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation. Violations of this rule will be cause for penalties against those responsible for the child committing the offense. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

The unsafe use of personal electronic transport devices, as determined by the competition officials and management in their sole discretion, that do not require a driver's license to operate, including but not limited to segways, hover boards, and single wheeled scooters is prohibited on competition grounds.

Operating such devices in areas where people gather may be deemed "unsafe use" if there is a risk of harm to others. If the operator of the device is a minor, the parent/legal guardian or individual who signs the entry blank as a parent or guardian of a minor operating the device in violation of this rule is accountable and may be subject to penalties. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

## **USEF POLICY ON SHARPS DISPOSAL (GR1210.4)**

Competition management shall place a minimum of one sharps container per each competition, whether or not stabling is provided. Additionally, at least one sharps container per fifty occupied stalls for the disposal of needles and other disposable sharp instruments in convenient locations in barns housing competition horses. It is competition management's responsibility to replace such containers when full and dispose of them properly. Competition management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments. Competition management will place a notice of this requirement either in its prize list or on a specific handout given to trainers on check in at the competition. If local law has different requirements, local law will prevail. Competitions failing to comply with placing the required number of containers on the show grounds will be considered in violation of the rules and may be subject to penalty as determined by the CEO or his designee and/or the Hearing Committee.



## 2025 Great American Insurance Group/USDF Regional Dressage Championships

A single Regional Dressage Championship program organized by the United States Dressage Federation (USDF), and recognized by the United States Equestrian Federation, Inc. (USEF), will be held in each of the nine USDF regions. In addition, Alaska and Hawaii may each hold state championships if an official request from a Group Member Organization (GMO) is received by April 1 of the prior year. The Regional Championship Program Rules can be found on the USDF website at [www.usdf.org](http://www.usdf.org). Please refer to the 2025 USDF Member Guide for the comprehensive list of rules and requirements for this program.

### Membership/Registration Requirements for Qualifying and Championships

*All memberships and registrations/recordings must be correct and current at the time qualifying scores are earned and at the time of the championships.*

Rider:

- Must have a USDF Participating\* Membership (PM).
- Must have a USEF membership (Active or Life).

Horse:

- Must have a USDF Lifetime Horse Registration (LHR).
- Must have a USEF (Annual or Lifetime) Horse Recording.
- USDF horse registration and USEF horse recording must be in the name(s) of the current owner(s) or lessee(s). A horse is not required to have breed registry papers.
- Horses must be entered in qualifying and championship classes under their official recorded names and ownership as specified in USEF GR1102.3, and transfers of ownership or lease registrations must be completed in compliance with USEF rules GR1105 and GR1108 prior to the competition in order for the horse to compete under the name of the new owner or lessee. (USEF DR127.2)

Owner:

- Must have a USDF Participating or Business Membership and a USEF membership (Active or Life Membership or Annual or Life Recorded Farm/Business). If the horse has more than one owner, at least one owner must have both active USEF membership and active USDF Participating or Business Membership and must be the owner of record with USEF and USDF. For a business or farm to be the valid owner under this requirement, it must be listed as an owner of the horse with both USEF and USDF.

\* PMs are USDF members who join USDF directly. USDF Group Members (GM) are ineligible.

**Minimum Qualifying Scores:** One set of nationally-standardized qualifying scores has been established for all USEF/USDF Regional Championships, for Training Level through Grand Prix, in three divisions: open, adult amateur and junior/young rider. FEI Junior and FEI Young Rider classes have only one respective division.

# ODS LICENSED CHAMPIONSHIP QUALIFICATION

ODS has offered an annual Championship Show since 1981. This show is traditionally the largest annual fundraiser for our organization and is a showcase of the best ODS horses and riders. You may qualify! Please join us for this wonderful event.

## QUALIFYING RULES

### General:

- Rider must be a **CURRENT ODS MEMBER** in good standing **AT TIME SCORES ARE EARNED**
- Each horse entered must be ridden by the same rider throughout the competition
- Additionally, at no time during the Championship competition may an entered horse be ridden by anyone other than the rider entered on that horse (with the exception of a groom walking on a loose rein)
- Attach photocopies of the front cover of the qualifying tests to the entry form

### Qualifying:

- **The qualifying season is September 1st of the previous year to August 25th of the current year**
- Qualifying scores must be earned by a **horse/rider combination**, they cannot be earned separately
- Only scores received at USEF/USDF Licensed shows may be used
- Only scores received using current USDF / USEF / FEI approved dressage tests count
- Championship scores will be calculated by averaging the percentages earned in the two tests ridden
- Scores from the following dressage tests do not count for the ODS Championship Show:
  - Dressage equitation
  - Dressage suitability
  - Rider tests
  - USDF Introductory Level
  - Opportunity classes
  - Lead line classes
  - Scores earned at ODS approved league shows and practice shows

### Championship Classes:

- Classes will be run under USEF/USDF Championship Rules
- Championship classes **must be ridden from memory**
- Whips are **not** allowed
- We will not be closing competition arena gates during tests, nor raking centerlines between riders.

### Tests:

- Tests selected for championship classes are at the discretion of show management
- Training–Fourth Levels will ride the two highest tests of the level
- FEI Championship classes will be judged by two judges
- Horse/rider combinations may enter two levels, but may only ride in one division (Open, Adult Amateur, or Junior/Young Rider)
- Horse/rider combinations winning Championship Show classes may not compete at that level in future championship classes (except FEI)

### Minimum Qualifying Scores:

- Entries must have earned two qualifying scores; per level, per division, and from two different judges at two separate competitions
- Qualifying scores may be earned at any test from the level
- The minimum percentages are as follows:
